MALE: -60kg, -66kg, -73kg, -81kg,  
-90kg, -100kg, +100kg

FEMALE: -48kg, -52kg, -57kg, -63kg,  
-70kg, -78kg, +78kg

- **Masters must be 30+ years old.**
- **Kosen competitors must by 17+ years old.**
- **Senior Novice divisions are yonkyu (green belt) and below. Senior Elite divisions are sankyu (brown belt) and above.**

### **IJF Juniors (Born 1998 – 2003):**

Female: 48, 52, 57, 63, 70, 78, +78kg

Male: 60, 66, 73, 81, 90, 100, +100kg

All competitors must declare and make their weight categories of competition at the official weigh-in. If the player is already registered in the higher weight division, then he/she can choose to play in the next highest weight division or receive a refund for the second division.**

**In consideration of being permitted to participate in any way, including travel to and from, in any Judo tournament, practice, clinic, and related events and activities of the Eastern Shore Judo Tournament on September 22, 2018, I hereby:**

- 1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo and the importance of following these rules.**
- 2. Agree that before participating, I have a right and duty to inspect the mats, equipment, facilities, to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach or supervisor of such condition(s) and refuse to participate.**
- 3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the action, inaction or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to one or not reasonably foreseeable at this time.**
- 4. Knowing the risks involved in the sport of Judo, I assume risk and accept personal responsibility for the damages following such injury, permanent disability or death.**
- 5. Through this waiver, release, discharge and covenant not to sue Eastern Shore Judo, Shore Christian Academy, Exmore Baptist Church or their respective administrators, directors, agents, coaches, and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, guardians, supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees of premises used to conduct the event, all of whom are hereinafter referred to as "released parties," from any and all claims, demands, losses, or damages on account of injury, including permanent disability and death of damage to property, caused or alleged to be caused in whole or in part by the negligence of the released parties or otherwise.**
